IMPORTANT: By signing this document, you are agreeing to waive certain legal rights that you may otherwise have, including the right to sue, please read this document carefully and in full before signing.

Please complete the required forms and turn them in at the Harbour Master Check-In prior to the event.

- WAIVER FORMS **MUST BE COMPLETED** IN ORDER FOR INDIVIDUALS TO PARTICIPATE.
- **BY SIGNING WAIVERS ALL PARTICIPATES ACKNOWLEDGE, UNDERSTAND AND AGREE TO THE FOLLOWING:**
 - That jumping into cold water from a frozen ice surface has certain risks and may result in serious injury, illness, other medical issues, or death. Participants should speak to their doctor prior to participating or allowing any minor to participate.
 - That the Take the Plunge is a fundraising event and media will be present which may result in photographs & video clips may be taken which may identify jumpers in various electronic and social media. Jumpers must consent to the use of their images as set out below.
 - That they understand that Innisfil Community Events Corp, Friday Harbour Resort Holdings Inc., and partners will take reasonable and appropriate safety precautions to connection with this event, each participant participates at their own risk.

Preamble:

Innisfil Community Events is a non-profit fundraising organization which puts on special events in Innisfil. Pledge proceeds received will be collected by Innisfil Community Events and will be donated on behalf of donors to the registered charities identified above. Each charity will receive 50% of the donated amount.

Although Friday Harbour Resort Holdings Inc., Innisfil Community Events and their respective employees, members, volunteers and partners will take reasonable precautions for the safety and security of the Take the Plunge event for participants, spectators, and others, Take the Plunge participants understand that there are inherent risks in this activity and that they are participating at their OWN RISK.

Rules and Conditions of Participation:

Your Safety:

1. All participants must be at least 18 years of age. Those under 18 must be accompanied by a parent and/or guardian who must sign the waiver and guidelines.
2. It is recommended to parents / guardians that children under the age of 9 years of age should not participate. Innisfil Community Events reserves the right to decline participation of anyone that in their sole discretion may be unhealthy or unsafe!
3. Emergency Personnel will be in attendance to ensure a safe event

What to wear:

1. Footwear to protect your feet on the way to and from your dip in the lake
2. Have a warm blanket and towels to cover yourself before and after the dip
3. It is recommended that a change of clothes be brought with you
4. Prizes awarded for best dressed costume ~ be creative

Registration & Pledges:

1. You must bring your pledge form and all money to the registration desk prior to your dip in the lake. Minimum Pledge is \$25 which will be your registration fee. The registration fee is used to cover insurance and other expenses needed in order to ensure a successful, safe and entertaining event.
2. Pledges in excess of \$25 registration fee will be turned over to the charitable cause above. Fundraising results will be announced in local media.
3. All cheques shall be made payable to Innisfil Community Events Corporation (ICE Corp), as collection agent, which are collected and, to the extent that they exceed \$25, will be donated on behalf of the donors, in equal parts, to the registered charities identified above.

On Polar Dip Day:

1. Register with INNISFIL COMMUNITY EVENTS starting at 11:00 AM at Harbour Master at Friday Harbour.
2. All participants must sign a waiver and acknowledgement. Registrants under the age of 18 must be accompanied by a parent and/or guardian, who also must sign waiver and acknowledgement.
3. Bring your pledge sheet and all donations. Upon registration you will be provided with a number which is the order you will do your Take the Plunge
4. You will receive an "I Took the Plunge" T-shirt upon registration.

- increase of change of exposure to, or infection by, diseases and infections, including COVID-19 and any variants thereof, through contact with other participants, guests, volunteers, employees, or management or contact with

common surfaces or object, or otherwise, at the Take The Plunge event.
